

- Highest decision-making body of the League
- Each member represented by its head of institution
- Meets twice a year
 - May 2014 at the University of Helsinki
 - November 2014 at the University of Milan
 - May 2015 at the Université de Genève
 - November 2015 at Imperial College London





Board of Directors

- Implements decisions of the Rectors' Assembly
- Monitors the budget
- Composition
 - Bernd Huber (Chair), President of LMU München
 - Andrew Hamilton, Vice-Chancellor of Oxford University
 - Alain Beretz, President of the University of Strasbourg





Policy Committee

- Consists of rectors, vice-rectors and senior academic managers from LERU universities.
- Develops LERU policy positions along a broad range of topics
- Chaired by Professor David Price (UCL)

- Valuable framework Should be continued
- How to progress in the next legislature
- a) BAU: cf. Council Conclusions Feb. 2104
 - Serious application of the European Semester? NRP-NCM... AGS
- b) Targeted legislative measures
 - Where clear need
 - Practical progress possible(OA, VAT on infrastructures equipments)
- c) ERA Framework Directive (Art.182,5 TFEU)
 - Passive prohibitions, no active obligations
 - Attribution, subsidiarity, proportionality
 - Politically realistic? Time frame?
